**Juror: Anne Garney**

Kansas City artist Anne Garney's paintings are a "celebration of life" and convey the joyful experience of painting in beautiful settings. Anne combines her love of travel with her love of painting, and particularly enjoys painting outside on-site because of the direct connection with the setting and the environment. Her favorite subjects are landscapes with beautiful buildings set amidst and against nature.

Anne's paintings have been featured in 60+ Art exhibitions in a variety of venues including the Albrecht-Kemper Museum, the Huntsman Gallery in Aspen, Colorado, the Wicker Wood Gallery on St. John, the St. Thomas Gallery in the U.S. Virgin Islands, and the Anguilla International Art Festival. Since the Spring of 2008, Anne has also been teaching Painting classes through the continuing education department at the Kansas City Art Institute. **Eligibility**

Artists age 18 and over are eligible to enter the exhibition. Must be able to hand deliver artwork.

Works accepted into any of IMAGES' past juried shows will be ineligible for jurying.

**Media & Specifications:** paintings in acrylic, oil, watercolor, pastel; drawing; original print-making; mixed-media; photography; sculpture and ceramics. Overall framed sizes cannot exceed 40" x 40".

**All 2-D work** must be framed (unless canvas with wrapped sides) and wired for hanging. Each work must be clearly labeled on the back with artist's name, address, telephone #, title of work, media, and price. **Right of Refusal:** any artwork that is substantially different from the entry, or damaged, will be declined.

**ENTRY PROCEDURE:**

**Entry Fee \$30.00 for up to 3 images. Digital images only.** Standard JPG format at 72 DPI with largest dimension of 7". Digital images must be placed on a CD and shall be named identical to the original artwork title to differentiate each work on the disk. The CD must be labeled with **artist's name** and **title of each entry**. The disk will not be mailed back to you, but may be picked up at the gallery during the exhibition. **Deadline February 29, 2012** Entry must be postmarked by February 29, 2012, and must include: entry fee, signed Agreement, Entry Form, CD with digital images, and a self-addressed stamped (#10) envelope for response.

**Insurance:** It is understood that IMAGES ART GALLERY assumes no responsibility for artworks on display. IMAGES ART GALLERY will exercise reasonable caution in handling and showing of artworks.

**Artworks must be for sale.** Artists will receive 70% on any piece sold. Prices stated on entry form should be adjusted accordingly. No change from entry price is permitted. All work must remain in the exhibition until exhibition closing.
